Any such powers and/or decision making ability of you (Robert Browne) and/or to act in any official capacity with ARC has been voted against by the board on July 31, 2013 (you are no longer a part of ARC resulting from this official vote on July 31, 2013). You are to make no decisions without the consent of the current board (Craig Hassapakis and Howard Clark). Furthermore, Robert K. Browne is NOT the ARC's Internet and/or business manager or have any other such titles and has no ability or official power to make decisions for ARC; these decisions are conducted by board vote only of current board members (Craig Hassapakis and Howard Clark).

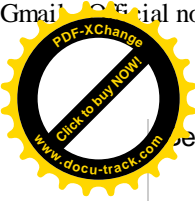
All official ARC emails must now be sent or received through the ARC gmail address redlist.arc@gmail.com

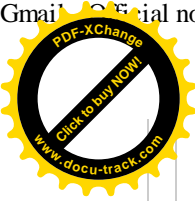
This is considered an official legal notice to Robert K. Browne (Belize) from ARC (Craig Hassapakis and Howard Clark)

It should be noted that continued operation of ARC is expected in the interim of any decisions regarding Robert Browne via email and ONLY his moral responsibilities of finishing any remaining papers in press and operations of the ARC website. No content changes to the ARC website at: redlist-ARC.org can be altered from its original designed content without dual permission of the acting principle operators of ARC (Craig Hassapakis and Howard Clark) as of July 31, 2013 and onward. Robert K. Browne (former associate of ARC) is to not act in any official capacity including but no limited to corresponding to anyone concerning ARC and its subsequent policy, operation, and/or function. Robert K. Browne's ability concerning any decision, policy, function, and any other activity concerning ARC are null and void subsequent to the official vote of the ARC board on July 31, 2013 (see notice immediately below here).
